1. Introduction

The protection of your privacy is important to us. The Salinen company group, especially Salinen Austria Aktiengesellschaft, FN 112541 b, Steinkogelstraße 30, 4802 Ebensee ("SAAG") and its affiliate Salinen Budapest will strictly abide by the statutory data protection provisions when processing your personal details, especially the rules and regulation in Act No. CXII of 2011 on the Right of Informational Self-Determination and on Freedom of Information ("Hungarian Privacy Act"). We have also taken technical and organisational measures to protect your details against loss, manipulation or unauthorised access.

Further provisions may be set forth in the general contract terms and provisions agreed in the course of purchase transactions managed.

The websites may contain links to other websites and webpages. In this case, Salinen Budapest is not responsible for the privacy policy or any other activity of such websites and webpages.

2. Responsible body and contact

The body responsible for processing your personal details (data administrator) is Salinen Budapest. If you have questions about data protection, please contact info@salinen.com or send us your query by post.

3. Collection, processing and use of personal data

3.1. We collect personal data only if you provide this to us voluntarily in the context of your order or when contacting us (e.g. via our contact form or by email). The data that we collect is evident from the respective input forms. This includes in particular your name, date of birth, email address, phone and/or fax number, your address for invoicing and delivery, and your payment information. Information or data related to you as user may, in accordance with the provisions of the Privacy Act, be transferred, for the purpose of data process, in order to provide services, to SAAG or its affiliates ("Salinen Company Group") We wish to point out that the personal data collected is stored within the European Economic Area (EEA), in especially Hungary and/or Austria on behalf of Salinen Budapest on a server belonging to SAAG.



You consent to the collection, processing and use of the personal details you have provided for the following purposes and on the following terms. Thus, the legal base for data processing is the consent of the user.

This consent can be revoked at any time in writing by letter to Salinen Budapest or by email to info@salinen.com

3.2. We use the details you have provided to us for fully processing the contract and for dealing with your enquiries, internal market research and marketing purposes, customer care, statistical purposes and improving the customer-friendliness of the websites.

3.3. For the fulfilment of the agreement we will pass your details on to the shipping company instructed to undertake the delivery insofar as this is necessary for the delivery of the ordered goods. For processing payments, we will forward the payment details necessary for this to the financial institution instructed to handle the payment and/or the payment services provider instructed by us or the payment service selected by you during the order process respectively. Your details will not be passed on to other third parties (i.e. to companies not belonging to the Salinen Company Group) without your agreement.

4. Right of information and deletion

We will store your details for as long as is necessary for the fulfilment of the purposes stated above or as long as we are obliged to do so by law. After this your personal details will be deleted. You also have the right to request information about your personal details that we have stored. If your details should be incorrect, incomplete or not relevant, we will correct or delete these on request. Please note that your details cannot be deleted in full in cases where there is a statutory duty of retention.

5. Use of cookies

To make visiting our website attractive and enable the use of certain functions we use cookies, which are small text files that are stored on your end device. Some of the cookies we use are deleted again at the end of the browser session, in other words after you close your browser (so-called session cookies). Other cookies will remain on your end device and enable us to recognise your browser on your next visit (persistent cookies). You can adjust your browser settings so that you are informed when cookies are installed and are able to decide individually about accepting cookies or excluding cookies, either in particular cases or generally. 6. Web analysis

We use Google Analytics, a web analytics service provided by Google, Inc. (www.google.hu).
